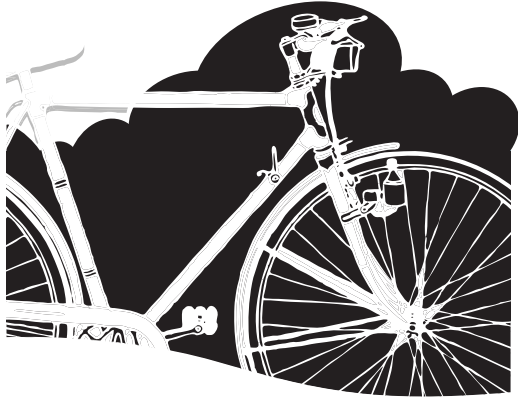

2. Continue straight on Rt 301S to La Plata.
3. Turn right onto Rt 6 West (Port Tobacco Road)
4. Follow Rt 6 approximately 17 miles to the Community Center on the left.

From Southern Maryland

1. Take Rt 301S to Rt 6W (Port Tobacco Road)
2. Follow the directions from #4 above.

Both sides of the registration form must be signed.

In consideration of being permitted to participate in any way in the Heritage Bike Ride, sponsored by the Commissioners of Charles County, Maryland, through its Department of Community Services, I, for myself, my personal representatives, assigns, heirs, and next of kin:

1. Acknowledge, agree, and represent that I understand the nature of bicycling activities, and that I am qualified, in good health, and in proper physical condition to participate in such activity; I further acknowledge that the activity will be conducted over public roads and facilities open to the public during the activity and upon which the hazards of traveling are to be expected. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.

2. Fully understand that: (a) bicycling activities involve risks and danger of serious bodily injury, including permanent disability, paralysis, and death (risk(s)); (b) these risks and danger may be caused by my own actions, or inactions, the action or inactions of others participating in the activity, the condition in which the activity takes place, or the negligence of others; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the activity.

3. Hereby indemnify and hold harmless the County Commissioners of Charles County, Maryland, and its officials, employees, and agents (the "County") from and against any and all liabilities, judgments, settlements, losses, costs, or charges (including attorneys fees) incurred by the County and/or any of its officials, employees, or agents as a result of any claim, demand, action, or suit relating to any bodily injury (including death), loss of property, damage caused by, arising out of, related to, or associated with this activity; and

4. I have read this agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and have signed it freely and without any inducement or assurance of any nature intended to be completed and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this Agreement is held to be invalid, then all remaining portions of this Agreement shall continue in full force and effect.
